## AN ORDINANCE AMENDING MAYFIELD CODE CHAPTER 15.20, FLOOD DAMAGE PREVENTION AND PROHIBITING ANY NEW DEVELOPMENT IN THE FLOODPLAIN AREA

WHEREAS, the Planning Commission of the Town of Mayfield (the "Commission") has

recommended that development in our floodplain area be prohibited; and			
WHEREAS, a public hea	ring was held by the Commission on	to review the	
flood zone and make recommendations for amending the existing Mayfield Town Code Chapter			
15.20 Flood Damage Prevention to Prohibit New Development in the FloodPlain Area ; and			
WHEREAS, no adverse comments were received during said public hearing; and			
WHEREAS, the Municipal Council of the Town of Mayfield (the "Council") held a public meeting			
on	to consider said recommendations; and		
WHEREAS, Pursuant to UCA 10-9a-505, the Council wishes to enact regulating land use and			
development in the Mayfield Town floodplain to protect life; and prevent the substantial loss of			
real property; or substantial damage to real property; and			
WHEREAS, The Council wishes to exercise their legislative authority and amend the Mayfield			
Town Code Chapter 15.20 to prohibit new development in our floodplain area as described in			
the Flood Insurance Rate Map (FIRM) Effective May 2, 2012 by the National Flood Insurance			
Program and our Floodplain Overview in our General Plan as prepared by Jones and DeMille			
Engineering on February 2	20,2018; and

NOW, THEREFORE, BE IT ORDAINED by the Municipal Council of the Town of Mayfield, Utah, as follows:


SECTION 1: Pursuant to UCA 10-9a-505, the Council enacts regulating land use and development in the Mayfield Town floodplain to protect life; and prevent the substantial loss of real property; or substantial damage to real property.

SECTION 2: The Council exercises their legislative authority and amends the Mayfield Town Code Chapter 15.20 to prohibit any new development in our floodplain area as described in the Flood Insurance Rate Map (FIRM) Effective May 2, 2012 by the National Flood Insurance Program and our Floodplain Overview in our General Plan as prepared by Jones and DeMille Engineering on February 20,2018.


